The Ski Council of Illinois (SKI) is headed to the Zermatt Resort and Spa in Midway, Utah, less than an hour from the Salt Lake City Airport (SLC).

## Package Includes

- Air transportation from Bloomington (BMI) 25 seats, Peoria (PIA) 25 seats (+\$25), and Springfield (SPI) 10 seats (-\$10)
- Round trip ground transportation SLC/Zermatt
- 7 nights lodging at the Zermatt, incl taxes, resort fees, tips for baggage handling
- 7 full hot breakfasts
- Lift Tickets – 2 days Park City, 2 days Deer Valley, 1 day Sundance including daily signup shuttle service with 2 time choices (may depend on number of skiers). Epic Day Pass lift tickets must be purchased online (see section explaining lift tickets)
- 20% group discount for on-site ski/snowboard rentals
- SKI contest with prizes and SKI group dinner
- Welcome reception with info for many non-skiing activities
- And ski with our exceptional host, Maxine!

## **Refund, Cancellation and Insurance information**

Cancellations penalties or itinerary deviations received from trip leader to Ski.com:

- 90+ days prior to departure (10/30), no penalty
- 89-60 days prior to departure (10/31-11/30), \$100 penalty, plus supplier penalties
- 59-31 days prior to departure (12/1-12/31), \$200 penalty, plus supplier penalties
- <30 days, no refunds or substitutions

Generally, but not always, some trip costs can be recoverable. Ski.com may be able to obtain adjustments for some unused group lift tickets. SKI may be able to make adjustments for some of their costs. And the airlines have waived their change fees for re-booking. Hotel costs are generally non-refundable. All are subject to each individual circumstance and are subject to change.

**Optional trip insurance** can be obtained through Ski.com for 6.5% of trip cost. Testing positive for COVID during the trip is covered. ## **Local Transportation**

- SKI recommends following this schedule for ski resort visits on specific days as follows: Sunday 1/30 & Monday 1/31 – Deer Valley, Tuesday 2/1 - Sundance, Wednesday 2/2 on your own, Thursday 2/3 & Friday 2/4 – Park City.
- City bus to Downtown Midway available in the evening.
- Resort shuttles to Downtown Park City may be available upon request.

### **Trip payment schedule**

Make checks out to SKI and send to trip leader. Trip costs will be adjusted for people who have purchased Epic and Ikon Season Passes.

- \$300 initial deposit
- \$400 September 25th
- \$400 October 25th
- Final payment due December 1<sup>st</sup>

### **Lift Ticket information**

- At **Park City/Canyons** group lift tickets are replaced by the Epic Day Pass.
  - Epic Day Pass – Are on sale and expected to increase September 7. They must be purchased by each member using this link: <https://ski-kouncil-illinois-passes.events.ski.com/epic-passes>. **You must order and pay for your own Epic Day Pass!** The cost of \$171 for an *Adult Epic 2 Day Restricted Pass* will be deducted from your SKI trip price.
  - Epic Season Pass – If you purchase an *Adult Epic Pass* or an *Adult Epic Local Pass* through Ski.com, you will receive \$40 off the trip price in addition to a refund of \$171 for an Adult Epic 2-day Restricted Pass from the trip price.
- At **Deer Valley** a 2-day Ikon group lift ticket is included in the price of your ski package with no additional action required. Group tickets must be used on consecutive days.
  - Season Pass – If you have purchased one prior to the trip you will be deducted \$270 for a Group 2-day Ikon Day Pass from the trip price.
- At **Sundance** a 1-day lift ticket is included. There is a \$100 deduction if you cancel.

### **Ski Rentals**

- Available at the Zermatt Resort the Adventure Haus gives SKI members a 20% discount in addition to a 20% discount for multiple rental days.
